#### Purchasing ethics :

To carry out its sustainable procurement policy, **INVIVO Group rely on the InVivo Group's code of conduct,** which specifies the fundamentals for its sales representatives/ buyers in terms of dialogue and balanced relations, professionalism, respect commitments, ethics, and pro-activity in the commercial relationship.

#### Reciprocity of commitments :

all of the InVivo Group's activities impose the same obligations and responsible attitudes on themselves in their purchases and ensure that the contractual conditions are negotiated fairly with their suppliers, that they are based in particular on respect of the respective rights and duties in particular in terms of ethics, terms of payment and balance of the contractual clauses and that they take into account the global costs over the entire life cycle of the products and services and the territorial responsibility supplier's organization.

InVivo Group's seek balanced performance and make their choices part of the ambition of a quality and lasting relationship.
